

CORNWALL NATIVE ESTABLISHES FUND FOR SCHOLARS

Will match contributions from the community up to \$10,000 annually through 2017



The Cornwall Central High School Scholar's Fund has been established by Cornwall native Jim Duff, Class of 1966. Jim created the fund at his alma mater to recognize three top scholars in the graduating class.

Beginning in June 2013, the overall top scholar in the graduating class, along with two separately identified students, who are the top math and science scholars, will each receive a \$1,000 scholarship. The focus is on students who have challenged themselves with a rigorous class load and who have performed at the highest level of achievement.

After his graduation from Cornwall Central High School and his parents' retirement to Florida, Jim moved away. He has lived in many areas of the United States, and has traveled extensively including every state and continent except Antarctica, but he has never forgotten his Cornwall roots. He was the youngest of six children, all of whom became successful and accomplished professionals. Jim himself retired from a high-level position with the Department of Interior. However, Jim credits his wife, Beth, who passed away in 2010 as his inspiration for his philanthropy and the creation of the *Cornwall Central High School Scholar's Fund*, one of many educational projects he has funded throughout the world.

Beth was active as a community volunteer and championed many causes including their church, missions, and people in need. "One of my wife's final comments as she waged her courageous battle with cancer was, "I thought I'd have more time," Jim said. Jim resolved to use the time he has to address charitable causes that are important to him, including this legacy for academically accomplished students graduating from Cornwall Central High School. "They no doubt will make this world a better place because they have challenged themselves and succeeded academically," added Jim.



Jim challenges the community to help "grow" the Cornwall Central High School Scholar's Fund by matching donations made by other citizens, up to \$10,000 annually, from 2013 through 2017. The community's contributions will help increase the number and amounts of scholarships in the future.



Donor Advised Funds

An effective, flexible solution for charitable giving.

Creating a Donor Advised Fund is easy when you partner with the Community Foundation. You establish and name your fund, and contribute a minimum of \$5,000. Donors are encouraged to "grow" their fund to a minimum of \$25,000 prior to recommending grants but may recommend pass-through grants while the fund is growing.

Then, at any time, you may:

- Consult our staff for timely, reliable information, whether you are looking for a charitable organization that supports your favorite cause or you are interested in exploring new causes.
- . Make additional tax-deductible contributions to your fund.
- Recommend grant distributions from your fund of at least \$250 to any 501(c) (3) public charity.
- · You choose recognition or anonymity.

Jane Unhjem was a vibrant educator, wife, mother, daughter, and community leader who passed away on August 18, 2012 from injuries sustained in the crash of a small airplane.

This Fund was established by her loving husband and college sweetheart, Erik. The Fund celebrates Jane's love of life, infectious energy, belief in the power of education, passion for the work of the Goshen Rotary Club's international exchange program for students and the music and arts programs in the Goshen Central School District.

The Jane Unhjem Memorial Scholarship will be awarded to a student to enable study abroad. Preference will be given to the graduating senior selected by Goshen Rotary Club for its Rotary Youth Exchange program. In years when the Club does not have a candidate, the scholarship will be awarded to a Goshen High School graduating senior who has been actively involved in the Goshen High School music program and is recommended by the Goshen High School music teachers for the award.

IRA CHARITABLE ROLLOVER EXTENDED! Good news for the charitably inclined and their tax advisors!

The American Taxpayer Relief Act of 2012 extended the IRA Charitable Rollover through December 31, 2013. This provision permits tax-free distributions to an eligible charity from an IRA held by someone age 70 1/2 or older of up to \$100,000 per taxpayer.

For many, an IRA is one of their most valuable assets. Donors who meet the age requirement can make a significant gift to charity without dipping into their other investments.

The distribution counts toward the required minimum distribution, and donors do not have to recognize the distribution as income. A direct gift from an IRA is a great way to accelerate charitable gifts. Two donors have already utilized this charitable technique in 2013 by making a gift of \$10,000 and \$25,000 respectively to a named fund administered by the Community Foundation.




