Museum Village Plans for the Future

Agency Endowment Fund Will Ensure Long-Term Sustainability

Museum Village, an open-air historical museum in Monroe, has established an Agency Endowment Fund at the Community Foundation of Orange and Sullivan. As the Museum's forward-thinking Board of Directors plans for the future, they created this fund to ensure long-term sustainability of the unique museum that offers visitors the opportunity to explore vignettes of 19th century American life.

Museum Village was established in 1950 by **Roscoe William Smith**, the founder of Orange & Rockland Utilities, Inc., with a vision to educate generations of Americans about the work and life of their ancestors. The Museum has been in operation for 68 years. Establishment of this new endowment fund is sweetened by the contributing force of the late Mr. Smith's granddaughter, **Nan Russell**, and her husband, **Pat**, who feel a special connection with the museum and its property. Nan had a close relationship with her grandfather and remembers fondly the time spent with him and his eclectic collection of historical pieces.

Amongst those in support of this latest plan for long-term financial planning is **Michael Sosler**, Executive Director of Museum Village. "This fund furthers the legacy of **Roscoe Smith** and his vision of 'Old Museum Village of Smith's Clove.' This will also prove the endurance of Museum Village and allow us to continue into the future. This endowment is being set aside to maintain the buildings and protect the valuable assets of this museum. Because of **Nan and Pat Russell's** generosity, future generations will enjoy this remarkable 19th Century Living History Museum for many years to come" said Michael.
