Rowley Family Foundation Fund for Women and Children Supports Coding Club for Newburgh Girls

Organizers say when the Newburgh Girls Code Club (NGCC) program was established, no one imagined the full impact it would have. The goal was to inspire girls to develop an interest in technology with the hope that they would be empowered to enter the field as they graduated high school.

As hoped, the program is certainly inspiring future careers. However, organizers say the amazing byproduct of this was the sisterhood that was cultivated by the girls working together, trusting one another, and forming friendships.

"Together, they explored and applied code principles addressing real topics they care about in our greater Newburgh community, and their daily lives. They grew as young leaders through the presentations they delivered, the panels they spoke on, the hackathons they participated in, and the industry mentors they connected with," said Mary Lou Carolan, Executive Director, Newburgh Free Library. "This kind of support system can't be taught; it must be experienced."

Organizers credit an initial grant from the Community Foundation's Fund for Women and Children as being the catalyst, and additional funding as the sustainable factor, for this successful youth coding program that has returned children to the Newburgh Free Library. Families who brought their children to toddler programs now have lifelong learning opportunities at the library for their children who are tweens and teens.

"The Newburgh Girls Code Club is one of the most exciting programs we have supported through our Fund for Women and Children," said Fund for Women and Children Founder Marianne Murray. "Our family has had the opportunity to observe the girls in action on several occasions and it is wonderful to see how engaged they are in the after-school sessions at the Newburgh Free Library. We are thrilled to support their continued excellent work."

The program recently launched the Intersections Podcast Program focused on teaching students that there are no losses in failure, only lessons. It reminds youth that it is more important to be brave than perfect, a central ethos to the nationally acclaimed Girls Who Code's network. Podcasting students are deepening their critical thinking, research capacities, and connection to the content they create.

NGCC and the Intersections Podcast Program have also provided a safe space for youth to explore their identities, particularly LGBTQ+ youth who are unsupported at home. 
Adopting T.H.E.O. Hosts Its First Annual Casino Night
